4. First Aid Measures

Inhalation

Sweep up and shovel, then place in suitable container for appropriate disposal.

Provide appropriate exhaust ventilation at places where dust is formed. Avoid contact with eyes, skin or clothing. Avoid prolonged or repeated exposure.

Storage

Store in a cool, dry place. Store in a tightly closed container.
